1) Candidates who failed or were absent for the RP examination on 2nd Saturday can re-apply for the same course scheduled on 4th Saturday. Registration for such candidates will open 4 working days after the 2nd Saturday exam date. Seats will be allotted on a first-come, first-served basis.

Example:

Candidates who failed or were absent for the Certificate Course in Foreign Exchange Operations exam held on 10.01.2026 (2nd Saturday) can register again for the same course from 15.01.2026 at 03:00 PM.

- 2) The RP examination will be conducted in 3 sessions a day. The session timings are 10.00 am to 12.00 pm, 12.45 pm to 2.45 pm, and 3.30 pm to 5.30 pm. Candidates can select the time of his/her choice.
