Conduct of DRA/DRA-TC examinations under Remote Proctored mode - Oct/Nov 2020.

COVID pandemic has affected many places of our country. Due to prohibitory measures introduced by various states to prevent the spread of the Corona Virus as directed by the concerned authority, most of the educational institutions are closed. Therefore, DRA/DRA-TC examination (physical classroom environment) scheduled from April was cancelled.

Considering the disruption created by the pandemic outbreak and changes in the environment, the Institute will be conducting DRA/DRA-TC under Remote Protected(RP) mode. Under this mode, the candidate is allowed to take examinations at a location/date/time of his/her choice. These examinations are conducted over the internet using a Desktop/Laptop which is to be arranged by the candidate himself.

DTA Institute may further note that:

- 1) The candidates who have enrolled for the DRA/DRA-TC examination in Apr'2020 and wishes to switch over to take-up the examination under remote proctored mode will also be able to register and give their consent.
- 2) Since the registration of application is through the DRA Training Institute, the training institute will be provided with a suitable option under their system/login to register the switchover option for the candidate by selecting the suitable date/time of examinations.
- 3) Once the candidate switchover/register for RP exam for a given date/time system will generate admit letter with login password and email it to the registered email id.
- 4) Examination fees of these candidates are already received by the institute, the same will be transferred to the remote proctored mode of examination. (the exam fee under both the mode is the same)
- 5) The DRA institute will also be able to register fresh candidates who have completed their training (Online mode/Offline) and their application is processed (application entered and remittance is processed).
- 6) **Registration will be on a first come first serve basis. We urge DRA Institute to register the candidates/process the remittance as early as possible to avoid disappointment.**

Candidates who do not switch over, need to wait till such time Institute decides about the physical mode of examination.
