Timeline for passing the exam – 9 months from the date of registration with GARP and a maximum of 2 attempts

# REGISTRATION PROCESS AT IIBF

**1**

JAIIB or CAIIB holders eligible to register through IIBF's website for the GARP-FRR course

**2**

A nominal amount of Rs. 1000 plus applicable taxes to be paid when registering through IIBF

**3**

The registration window to remain open every quarter

- **July 1 - July 31, 2021**
- **October 1 – October 15, 2021**
- **January 1 – January 15, 2022**
- **April 1 – April 15, 2022**

**4**

Details of all registered candidates will be shared by IIBF to GARP after closure of each quarter registration window.

**5**

GARP will then communicate to the registered email ids the registration link for the FRR course at a **preferential rate of USD 300.**
