## **Programme on Export and Import Finance for Bank Officials (Physical Classroom Session)**

### **BACKGROUND**

Unlike traditional domestic lending, cross-border financing requires Credit Officers to operate at the intersection of international trade law, fluctuating currency markets, geopolitical barriers, and stringent compliance frameworks.

This comprehensive 3-day certification training program is specifically mapped out to transform credit professionals into robust trade finance and FX practitioners. Moving methodically from standard pre/post-shipment financing and structural credit channels into the intricacies of FX treasury operations and derivative mitigation tools, this program ensures that participants gain the technical expertise needed to prudently analyze, structure, and monitor international exposures.

### **Core Learning Objectives**

- Master Regulatory Architecture: Comprehend and apply key ICC rules including UCPDC 600, URDG 758, and Incoterms 2020 rules within structural appraisals.
- Deconstruct Trade Mechanics: Vet complex Letter of Credit (LC) clauses and International Bank Guarantees to identify hidden legal risks and discrepancies.
- Structure Funding Facilities: Master calculations and end-use monitoring for Export Packing Credit (EPC), PCFC, and post-shipment bill discounting.
- Evaluate Import Channels: Structure optimized short-term facilities including Trust Receipts, Buyer's Credit, and Supplier's Credit.
- Mitigate Currency Mismatches: Analyze how foreign exchange volatility impacts a corporate borrower's debt service capabilities and model proper forward or option hedges.
- Identify Trade Fraud: Execute forensic document checks to detect Trade-Based Money Laundering (TBML) markers like over/under-invoicing or duplicate bills.

This program is custom-tailored for professionals seeking to elevate their credit underwriting, risk assessment, and asset management capabilities, including:
